Rosettes sponsored by Lubrisyn will be awarded for the lowest dressage score in each class except 1b, 1c and 2c.

*In support of safe riding on the cross country course, a ribbon is also awarded in each class, except 1b, 1c and 2c, for nearest **optimum time**. The optimum time for each level will be listed on the cross country course plan.*

CONDITIONS:

- No dogs are allowed at Battle Hill under any circumstances
- The Event is run under NZPCA rules with **gear inspection at every phase**
- Approved helmets (AS/NZS 3838, PAS 015, BSEN 1384, EN 1384, ASTM F1163) must be worn at all times while mounted.
- Medical arm bands must be worn during show jumping and cross country phase at all levels.
- Back protectors are **compulsory** for the cross country phase. Clothing with a zip front cannot be worn for cross country.
- Refunds will be at the discretion of the committee, less 20%. A vet or doctor's certificate must be provided for a refund to be considered.
- The Battle Hill Event Management Committee reserves the right to alter, close and/or restrict the programme.
- Protests must be written and formally lodged with the Event Secretary accompanied by a refundable (if protest upheld) \$30 fee within 15 minutes of the score being posted.
- Competitors and spectators enter the grounds at their own risk.
- Battle Hill is open to the public and riders must take care and caution.
- No commanded dressage tests except for Class 4 i.e. tests may only be read out for the two Intro classes.
- Whips: Refer NZPCA Horse Trials Gear Inspection Checklist - October 2009 (NZPCA website > resources)
- Riders in Classes 1, 2 and 3 who are eliminated in the cross country phase **may not** continue. Riders in Class 4 who are eliminated in the cross country phase may continue but must give way to other riders.
- Riders must be in correct formal riding attire for ribbon presentation (unmounted).
- All riders are to nominate a fence judge (who is aged 16 or over).
- **Rubbish and manure:** No rubbish collection service is available at Battle Hill; please take away ALL your rubbish. Please clean the twine, manure and hay from around your float or truck and place manure at site located next to Pony Club Shed or the Poo trailer provided.
- The Battle Hill Events Committee adheres to the NZPCA Fair Play Charter and asks all participants to respect these.
- The decisions of the judicial committee are binding and final. No confrontation with judges or officials will be tolerated and may lead to elimination.

Vet and First Aid: Julia Bryce from Lakeside Vet Centre will be present for the cross country phase and **Wellington Free Ambulance** will be on site for all jumping phases.

There will be food and drinks available for purchase
